

**FACTS****WHAT DOES RIGHTSIZE FUNDING DO WITH YOUR PERSONAL INFORMATION?**

<b>WHY?</b>	Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some by not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.
<b>WHAT?</b>	The type of personal information we collect and share depend on the product or service you have with us. This information can include: <ul style="list-style-type: none"> <li>• Social Security number and Income</li> <li>• Transaction and Payment Histories</li> <li>• Account Balances</li> <li>• Credit Scores, and Credit History</li> </ul>
<b>HOW?</b>	All financial companies need to share customers' personal information to run their everyday business. In the section below, we list the reasons financial companies can share their customers' personal information; the reasons that RightSize Funding choose to share; and whether you can limit sharing.

**Who We Are****Who is providing this notice?**

LRE of Nevada, LLC dba RightSize Funding and its affiliates, which include financial companies and used car dealerships.

**What We Do****How does RightSize Funding protect my personal information?**

To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings.

**How does RightSize Funding collect my personal information?**

We collect your personal information, for example, when you:

- Apply for a loan or provide account information;
- Provide employment information; and
- Give us your contact information.

We also collect your personal information from others, such as credit bureaus, affiliates, or other companies.

**Why can't I limit all sharing?**

Federal law gives you the right to limit only:

- Sharing for affiliates' everyday business purposes— Information about your creditworthiness;
- Affiliates' from using your information to market to you; and
- Sharing for nonaffiliates to market to you.

State laws and individual companies may give you additional rights to limit sharing. Please see below for additional information.

**What happens when I limit sharing for an account that I hold jointly with someone else?**

Your choice will apply to everyone on your account.

**Definitions****Affiliates**

Companies related by common ownership or control. They can be financial companies and nonfinancial companies.

- Our affiliates include HLS of Nevada, LLC dba Nevada West Financial, and Southern Nevada Auto Sales, LLC dba Open Lot.

**Nonaffiliates**

Companies not related by common ownership or control. They can be financial and nonfinancial companies.

- Nonaffiliated companies include companies and dealerships that have a contractual relationship with RightSize Funding and/or its affiliates.

**Joint Marketing**

A formal agreement between nonaffiliated financial companies that together market financial products and services to you.

**Other Important Information**

The following entities are providing you notice jointly: LRE of Nevada, LLC dba RightSize Funding, HLS of Nevada, LLC dba Nevada West Financial, and Southern Nevada Auto Sales, LLC dba Open Lot.

**Nevada Residents Only:** This notice is provided to you pursuant to state law.
